Walk-in interview for the Post of Research Associate for a Consultancy Project at IIM Lucknow

One Research Associate is required to review the exchange-related disclosure, the Securities and Exchange Board of India's (SEBI) master circular on regulatory architecture of equity and commodity, and reports of the national and international regulatory institutions, namely Securities Exchange Commission (United States), Commodity Futures Trading Commission, Financial Services Authority (United Kingdom), Chinese Securities Regulatory Commission, International Organization for Securities Commission, BIS, and so on, and interaction with macro- (exchanges and regulators) and meso-level (exchange members) stakeholders for the consultancy study titled '**Regulatory landscape in equity derivatives versus commodity derivatives markets in India**' undertaken by the IIM Lucknow. Job Description:

- Conduct key informants' interviews, viz. exchange members, senior officials of exchanges, and regulatory institutions.
- Analysis, and report writing as per objectives of the study
- TA/DA will be paid extra for outstation visits as per the policy of the institutions/central government autonomous bodies.

Preferred Skills and Experience: Preference will be given to a candidate who has experience in derivatives market and has a fair understanding of market microstructure, exchange working and regulatory architecture of derivative market (commodity & equity).
