

2	Please refer Termination of Contract page-3: The advance notice period for termination of contract by any party is mentioned 2 months. But the same at page-5, under heading Termination/ Extension is mentioned 3 month. Kindly confirm that this will be read as 2 months or 3 months.	Please note the advance notice period for termination of contract by any party is mentioned as two (2) months be treated/read as three (3) months.
3	Please refer Annexure-1. Point 3 (5) Annual Routine point-5 page-7; Here it is mentioned that Cleaning of outdoor premises of STP. But any measurement i.e. area, distance etc. is not mentioned. Kindly confirm the quantum of work.	Cleaning of outdoor premises of STP be treated/noted as inside fenced area of STP Plant.
4	Please refer point 5 page-5 Battery Limit: The battery limit is defined within the fenced area. But further it is mentioned "However, incoming sewer line up to sump well of SPS and power connection up to the main control panel. We understand that that work beyond sump well and main electrical panel is not in tenderer scope. Kindly confirm.	Cleaning of outdoor premises of STP be treated/noted as inside fenced area of STP Plant.

In case of Preventive Operation & Maintenance the Institute will provide the chemical for Chlorination. In case of Comprehensive Operation & Maintenance the chemical for Chlorination will be provided by the contractor.
6	Refer Price Bid: There are two price bid format i.e. Annexure-III and Annexure-IV. Annexure-III is for Preventive Maintenance while Annexure-IV is for Comprehensive AMC. In tender document Preventive Maintenance Scope is given but Comprehensive AMC scope is not given. In such condition how one could quote the rates at Annexure-IV.	Please note in case of Comprehensive AMC, complete Operation & Maintenance will be done by the contractor. The same has been also mentioned in the BOQ (Bill of Quantity).

Tenderers are advised to upload scanned image of EMD and send original EMD in a sealed envelope through SPEED POST, Courier Services to IIM Lucknow before the due date. The EMD sealed envelope shall marked the tender details. Indian Institute of Management Lucknow Campus reserves the right to accept or reject any or all the tenders without assigning any reason. E.M.D. of unsuccessful tenderer will be released after the award of work to successful tenderer.

Introduction (Definitions)

- a) The “IIM Lucknow” means Indian Institute of Management Lucknow.
- b) “Bidder” means the individual or agency who participates in this tender and submits its bid.
- c) Work Order means the order placed after issue of letter of intent by the IIM Lucknow to the agency signed.
- d) The Contract Price means consideration payable to the agency under the work order for the full and proper performance of its contractual obligations.

Validity Period of Bid
