Eligibility Criteria

The bidder must submit:

Scope of Work

The following shall be carried out by the implementation vendor.

- 1. This Tender for AMC of Network Switches and Access points (list attached Annexure B and C) spread over at IIM Lucknow & Noida Campus is for a period of one year. If the services are found satisfactory, this contact can be extended further for another next two years on the same terms and conditions.
- Vendor to configure and install the equipments with latest IOS. (according to IIML's requirement).
- This tender is to provide Annual Maintenance Service of all network equipments which includes all the switches and access points which is active in the network at the time of tendering.

- 4. Your responsibility includes monitoring and management of networks, and network devices which are listed in Annexures B & C.
- 98% uptime of the Network Equipments are to be guaranteed by the vendor. Response Time:30 min-2 hrs and Resolution time: 2Hrs. to Next Business Day. Uptime will be calculated on quarterly basis.
- A hardware problem must be resolved within 2 days of the complaint date. After that a
 penalty of Rs. 500/- per day will be levied and total penalty will be deducted from quarterly
 payment.
- Monthly/quarterly status report of the services of network and network equipments which are covered under AMC should be submitted to IIML with full details.
- 8. On the basis of performance and SLA (Service Level Agreement), IIML may cancel this work order with prior notice. Notice period depends on the severity of the issues.
- Any payment made by IIM Lucknow in respect of the AMC done will be subject to income tax and any other applicable taxes deductable at source at the rate in force from time to time.
- 10. The payment shall be made at the end of each quarter after satisfactory performance. You have to submit a performance / Preventive Maintainance report along with the invoice at the time of submission of Bill.
- 11. If any vendor would like to evaluate the equipments and facilities, you are free to visit our Lucknow / Noida Campus for the same.
- 12. You have to provide list of items with serial numbers on letter head from OEM ensuring the **back to back** support available at Lucknow / Noida Campus.
- 13. You have to provide list of items with serial Numbers on Letter head ensuring the support for all items which <u>does not have a back-to-back</u> support from OEM with how to maintain it.
- 14. You have to keep sufficient stand-by spares at Lucknow / Noida Campus.

Terms and Conditions

The bidder must ensure:

A) Pricing:

 Quote price for each of the components and also the total amount as per the tender document.

- The prices are to be quoted on individual item rather than the total packageincluding all taxes.
- Need not suggest any alternative product or different configuration in the same product.
- The quotations are invited on two bid system (Technical and Financial) for procuring the above items.

B) Payment Terms:

- The payment shall be made at the end of each quarter after satisfactory performance. You have to submit a performance / PM report along with the invoice at the time of submission of Bill.
- The final payments will be made based on the Preventive Maintainance completion certificate.

Late Bids

Bids received after the due date and the specified time for any reason whatsoever, shall not be entertained.

Disqualification

The proposal is liable to be disqualified in the following cases:

- 1) Proposal not submitted in accordance with this document
- 2) During validity of the proposal, or its extended period, if any, the bidder increases his quoted prices.
- 3) Proposal is received in incomplete format
- 4) Proposal is received without soft-copy of the EMD.
- 5) Proposal is not accompanied by all requisite documents.
- 6) Information submitted in the e-tender proposal is found to be misrepresented, incorrect or false, accidentally, unwittingly or otherwise, at any time during the processing of the contract (no matter at what stage) or during the tenure of the contract including the extension period if any.
